I. APPLICATION REQUIREMENTS

- Being graduated from an undergraduate program (4-year) of a higher education institution recognized by the Higher Education Council.
- For master program candidate having at least 475 in GMAT (Graduate Management Aptitude Test) or 650 in "quantitative" section of GRE (Graduate Record Examination)
- For PhD program candidates having at least 500 in GMAT (Graduate Management Aptitude Test) or 685 in "quantitative" section of GRE (Graduate Record Examination)
- For PhD program candidates being graduated from an undergraduate or graduate program with a graduation grade which is at least 3.00 over 4.00 or equivalent
- Being successful in the interviews made face-to-face or online.
- For master degree and PhD candidates also having a successful grade from English Proficiency Exams and accepted by İzmir University of Economics.

The scholarships are valid for 2012-2013 Academic Year. This does not cover the scholarship applications for following years.

The Required Documents for Application

- Diploma
- Application form for graduate programs
- Transcript
- 2 reference letters
- English proficiency certificate if available.
- Upon entry into Turkey, foreign students must apply for a "Temporary Residence" Permit from the local Department of Police,
- All Foreign nationals who are admitted to Izmir University of Economics must apply for a Student Visa, (Student Visa applications are made to the Turkish Embassies and Consulates in the student"s home country.)
- Financial assurance to have education in the University

Evaluation of Applications

The applications will be evaluated in accordance with the quotas reserved for the countries by the Board of Trustees. Fulfilling the necessary conditions does not guarantee taking scholarship. The Board of Trustees will give the final decision for determining the scholarship students after the evaluation of applications by the related commission.

Evaluation results will be published on University's web page.

The scholarships awarded by the Izmir University of Economics do not bind the students with any financial or service obligations.

Undergraduate diplomas taken from institutions recognized by Higher Education Council of Turkey are valid. IUE **has to** officially consult to Higher Education Council of Turkey(YÖK) about the accreditation of diplomas of candidates.
